

## Clinical Policy: Crisaborole (Eucrisa)

### Description

Crisaborole (Eucrisa™) is a phosphodiesterase 4 inhibitor.

### FDA Approved Indication(s)

Eucrisa is indicated for the topical treatment of mild to moderate atopic dermatitis in adult and pediatric patients 3 months of age and older.

### Policy/Criteria

*Provider must submit documentation (such as office chart notes, lab results or other clinical information) supporting that member has met all approval criteria.*

It is the policy of health plans affiliated with Centene Corporation® that Eucrisa is **medically necessary** when the following criteria are met:

#### I. Initial Approval Criteria

##### A. Atopic Dermatitis (must meet all):

1. Diagnosis of atopic dermatitis;
2. Age  $\geq$  3 months;
3. Failure of a 2-week trial of two generic medium-to-very high potency topical corticosteroids of different molecular identities, unless contraindicated (e.g., areas involving the face, neck or intertriginous areas) or clinically significant adverse effects are experienced;
4. Dose does not exceed 60 grams (1 tube) per 30 days.

**Approval duration:** 6 months

##### B. Other diagnoses/indications (must meet 1 or 2):

1. If this drug has recently (within the last 6 months) undergone a label change (e.g., newly approved indication, age expansion, new dosing regimen) that is not yet reflected in this policy, refer to one of the following policies (a or b):
  - a. For drugs on the PDL, the no coverage criteria policy: CP.PMN.255; or
  - b. For drugs NOT on the PDL, the non-formulary policy: CP.PMN.16; or
2. If the requested use (e.g., diagnosis, age, dosing regimen) is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized) AND criterion 1 above does not apply, refer to the off-label use policy: CP.PMN.53.

#### II. Continued Therapy

##### A. Atopic Dermatitis (must meet all):

1. Member meets one of the following (a or b):
  - a. Currently receiving medication via Centene benefit or member has previously met initial approval criteria;
  - b. Member is currently receiving medication and is enrolled in a state and product with continuity of care regulations (*refer to state specific addendums for CC.PHARM.03A and CC.PHARM.03B*);
2. Member is responding positively to therapy;
3. If request is for a dose increase, new dose does not exceed 60 grams (1 tube) per 30 days.

**Approval duration:** 12 months

**B. Other diagnoses/indications (must meet 1 or 2):**

1. If this drug has recently (within the last 6 months) undergone a label change (e.g., newly approved indication, age expansion, new dosing regimen) that is not yet reflected in this policy, refer to one of the following policies (a or b):
  - a. For drugs on the PDL, the no coverage criteria policy: CP.PMN.255; or
  - b. For drugs NOT on the PDL, the non-formulary policy: CP.PMN.16; or
2. If the requested use (e.g., diagnosis, age, dosing regimen) is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized) AND criterion 1 above does not apply, refer to the off-label use policy: CP.PMN.53.

**III. Diagnoses/Indications for which coverage is NOT authorized:**

- A.** Non-FDA approved indications, which are not addressed in this policy, unless there is sufficient documentation of efficacy and safety according to the off label use policies – CP.PMN.53 or evidence of coverage documents.
